The MLS Rules & Regulations course must be completed within 120 days of becoming a MLS participant/subscriber. *Notice: Approved Motion from the GNIAR Board of Directors Meeting – January 18, 2012* “A motion that MLS services would be suspended if mandatory MLS Rules & Regulations training is not taken by new Participant/Subscriber within 120 days and services will remain suspended until class is taken, in addition to paying a \$25.00 reinstatement fee after the class is taken.” (GNIAR only members this MLS Rules & Regs course does not apply) Your opportunities to take this course will vary depending upon when you became a MLS participant/subscriber.

**Please Note:** Failure to satisfy this requirement within the specified timeframe from date of application may result in denial of the membership application or termination of PROVISIONAL MEMEBERSHIP and assessment of applicable fees to rejoin the Association. (Refer to GNIAR bylaws Article V Sections 2, 3 & 4)

Staff is not authorized to grant extensions of time. Extensions may only be made by approval of the GNIAR Board of Directors.
